

Culpeper: Contact Your Elected Officials About Disruptions from Data Center Expansion

Culpeper has approved **over 10 million square feet of new data center space**, in addition to what has already been built. As these industrial buildings encroach on neighborhoods, the noise and traffic during their construction, as well as the ongoing noise and air pollution, water and electricity use, and appearance and night lighting from the completed structures will impact local residents' quality of life.

Let your Town Council, Board of Supervisors, and State Representatives know if you are being impacted by construction traffic, noise, blasting, dust and other effects of Culpeper's data center boom. Call or send an email to your elected officials.
